Section 2. That the City Manager is hereby authorized and empowered to amend FY'78 SB 174 State Block Grant Contract No. 619.0BG3F-005, to provide for the development of the Fletcher Elementary School playground rather than the acquisition of land for Linda Vista Neighborhood Park No. 2.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
