AN ORDINANCE INCORPORATING 10.4 ACRES ALONG BOTH SIDES OF 30TH AND FERN STREETS, FROM GRAPE STREET TO CEDAR STREET, EXCLUSIVE OF THE FRONTAGES ON THESE LATTER TWO STREETS, IN THE GREATER GOLDEN HILL PRECISE PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A AND CC ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0427 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12795, APPROVED APRIL 14, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows.

Section 1. That 10.4 acres along both sides of 30th and Fern Streets, from Grape Street to Cedar Street, exclusive of the frontages of these latter two streets, in the Greater Golden Hill Precise Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2A" and "CC" on Zone Map Drawing No. C-645.2, be, and it is hereby incorporated into R-2A and CC Zones, as such zones are described and defined by Sections 101.0410 and 101.0427 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12795, approved April 14, 1930, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.

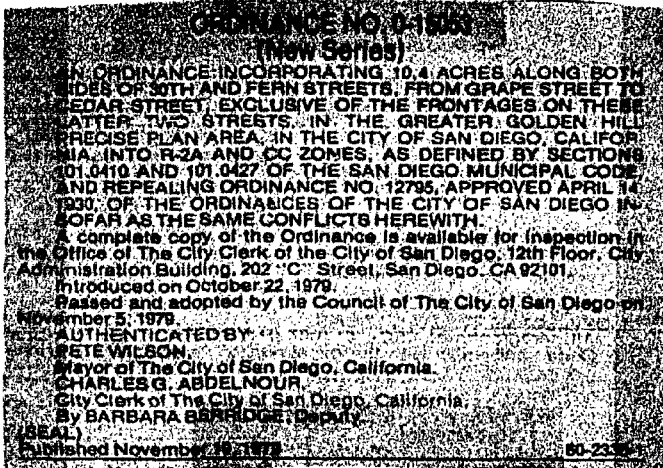
