BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Public Resources Code, Section 21081, the following findings are made with respect to the environmental impacts identified in Environmental Impact Report No. 77-08-49:

The noise impact will be mitigated to the level of insignificance by incorporating the following measures:

1. The building to be arranged on the site so as to shield the grassed and recreation areas. Also, the layout of the apartments will be such that the entries for each will face into the grasses or recreation areas, away from the noise source.

2. The construction will meet the requirements of Article 4 of the California Noise Insulation Standards where required.

3. Air conditioning will be provided to each apartment so that the windows will not need to be opened for air circulation.

4. The landscaping between the street and the building will also help in the control of the noise level.
