BE IT RESOLVED, by the Council of The City of San Diego, as follows:

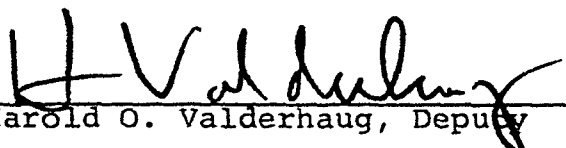

Paynter, which deed reserves to the Grantor a life estate, affecting Lots A, B and C, Block 225, Mission Beach, as more particularly described in said deed.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with Mrs. Paynter, which agreement sets out the terms and conditions of the donation of her property to the City and the form of which is on file in the office of the City Clerk as Document No. 762341.
