


RESOLUTION No. 220028 (R-78-12/7)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$340,745.00 by Mike Masonovich Constr. Co. Inc., a corporation for CONSTRUCTION OF ENCANTO TRUNK SEWER PHASE II, in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 761698.
2. That the expenditure of \$392,345.00 is hereby authorized out of the Sewer Revenue Fund 506 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$53,955.00 within Sewer Revenue Fund 506 from Sewer Construction Outlay 64.92 to the Unallocated Reserve 69.97.
