


RESOLUTION No. 220029 (R-78-1216)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$84,321.50 by JOSEPH E. O'BERRY, an individual, dba O'BERRY ENGINEERING, for THE IMPROVEMENT OF OCEAN VIEW BOULEVARD, 37TH STREET, 41ST STREET, COTTONWOOD STREET AND BIRCH STREET - (Contract No. 3), in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 761500.
2. That the expenditure of \$37,800.00 is hereby authorized out of the First Year Block Grant Fund 2910 and that the expenditure of \$48,650.00 is hereby authorized out of the Second Year Block Grant Fund 290 and that the expenditure of \$4,250.00 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.




