

RESOLUTION OF INTENTION NO. 220045

JAN 11 1978

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE PORTIONS OF CLAIREMONT MESA BOULEVARD AND MERCURY STREET AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the streets hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of portions of CLAIREMONT MESA BOULEVARD and MERCURY STREET as more particularly shown on Drawing No.13865-B on file in the office of the City Clerk as Document No. 762349.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."


