

RESOLUTION No. 220052 (R-78-1108)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of a street easement deed of NAUTILUS INVESTMENT COMPANY, INC., a California corporation, executed in favor of The City of San Diego, bearing date of May 27, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that real property in Lot 2, Block 6, Swan's Addition, as more particularly described in said deed, be, and the same is hereby dedicated as and for a public street, and the same is hereby named MENLO AVENUE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
