WHEREAS, the Department of Justice Law Enforcement Assistance Administration (LEAA) has awarded the National District Attorney's Association a grant for the purpose of providing technical and assistance to prosecutorial agencies; and

WHEREAS, such aid consists of a team of experienced consultants reviewing administrative procedures followed in processing all documents related to the prosecutorial function; and

WHEREAS, the team thereafter reports upon perceived areas of personnel and other problem areas and recommends procedures to streamline administration in order to save time and money; and

WHEREAS, prosecuting agencies across the nation are required, by formula, to provide a minimal cash match to help defray expenses with LEAA paying all other costs; and

WHEREAS, said cash match for The City of San Diego is \$1,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby directed to transfer within the General Fund 100 the sum of \$1,500 from the Unallocated Reserve (53.31) to the Allocated Reserve (53.20) to be used as a cash match for the conduct of a management study provided by LEAA of the prosecutorial function of said City of San Diego.
