

RESOLUTION OF INTENTION NO. 220099 (B. 78-1194)
JAN 18 1978

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE THE ALLEY IN BLOCK 25 OF DEL MAR HEIGHTS, MAP 157, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of the alley in Block 25 of Del Mar Heights, Map 157 hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of the alley in Block 25 of Del Mar Heights, Map 157, as more particularly shown on Drawing No. 14036-B on file in the office of the City Clerk as Document No. 762395.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."


