
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an agreement with HARRY L. SUMMERS, INC., a California corporation, for the installation and completion of certain public improvements in the subdivision to be known as UNIVERSITY GARDEN VILLAS, formerly identified as UNIVERSITY GARDENS UNIT NO. 2.

BE IT FURTHER RESOLVED, that the subdivision improvement agreement for UNIVERSITY GARDENS UNIT NO. 2, on file in the office of the City Clerk as Document No. 739453, heretofore executed on March 24, 1972, be, and it is hereby terminated, and the Instrument of Credit issued by Central States, Southeast and Southwest Areas Pension Fund submitted as improvement security for the performance of public improvements and the setting of stakes and monuments in said subdivision, be, and it is hereby released.
