RESOLUTION NO. 220133

A RESOLUTION OF INTENTION TO FORM JAN 25 1978 SAN DIEGO OPEN SPACE PARK FACILITIES DISTRICT NO. 1

RESOLVED, by the City Council of the City of San Diego, as follows:

- 1. The public interest and convenience require and this Council proposes to form a district to be known as the San Diego Open Space Park Facilities District No. 1, for the purposes of acquiring open space and other park facilities, pursuant to the San Diego Park Facilities District Procedural Ordinance.
- 2. The boundaries of the proposed district shall be coterminous with the exterior boundaries of the City and are delineated on a map entitled Map of Boundaries of San Diego Open Space Park Facilities District No. 1, San Diego County, California, on file with the City Clerk and open to public inspection.
- 3. The Council proposes to form the district for the purpose of submitting to the voters of the district a proposition of incurring a bonded indebtedness to provide funds for the acquisition of open space and other park facilities.
- 4. Reference is hereby made to a map entitled "Potential Park Reserve System" which, as now constituted or as from time to time amended or revised, identifies the properties subject to consideration for acquisition by the proposed district, copies of which are on file with the City Clerk and the City Planning Department and open to public inspection.



- 5. The district contains all of the properties within the City that will be benefited by the proposed acquisitions.
- 6. On Monday , March 20 , 1978, at the hour of 2: P.M., in the Council Chambers, Charles C. Dail Concourse, 202 C Street, San Diego, California, the City Council will (i) hear any persons interested in the formation of the district, the inclusion within the district of any lands, or the purposes for which the district is being formed and (ii) consider and finally act on the formation of the district.
- 7. Owners of real property within the proposes district may, up to the hour fixed for the hearing, file with the City Clerk written statements signed by them stating the grounds on which they are for or against the formation of the district or why their properties will or will not be benefited by being included therein; and such persons may appear in person at the hearing and present evidence in support of their written statements.
- 8. Copies of this resolution, together with the names of the members of the City Council voting for and against it, shall be published once a week for at least two successive weeks in the Daily Transcript, a newspaper of general circulation printed and published in the City, and shall also be posted in three public places within the proposed district.
- 9. Notice of the adoption of this resolution and of the time and place fixed for hearing, shall be mailed, postage prepaid, to each person to whom land in the proposed district is



assessed, as such owner is shown on the last equalized County assessment foll, including persons so shown who own possessory interests therein, and to each person who files in the office of the City Clerk a written request expressly referring to this Resolution or the proposed district and setting forth his name, his address and a designation of the land within the proposed district in which he claims an interest.

10. The posting and mailing and the first publication shall be not more than 60 days nor less than 30 days prior to the day fixed for the hearing.
