WHEREAS, City staff is currently preparing for a hearing on the creation of a City-wide Park Facilities District pursuant to authority of Ordinance No. 12027 N.S. (San Diego Municipal Code Section 61.2000 et seq.) adopted by the San Diego City Council on February 3, 1977; and

WHEREAS, Ordinance No. 12027 N.S. requires that a mailed notice of the hearing be made to each of the 265,000 property owners within the City; and

WHEREAS, an information center is needed, with staff equipped to handle the numerous telephone calls that the mailed notices will generate; NOW, THEREFORE,

BE IT RESOLVED, that the expenditure of \$25,000 from the Environmental Growth Fund (2505) is hereby authorized solely and exclusively for the purpose of financing the above mentioned nonrecoverable expenses to be incurred in connection with the PROPOSED SAN DIEGO OPEN SPACE PARK FACILITIES DISTRICT NO. 1.
