

RESOLUTION NO. 220139Adopted on JAN 25 1978

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
5206 Frances L. Greer	Library	\$330	Ms. Greer is a Book Repairer. She suggested that monthly magazines no longer be reinforced. A trial period established that this does not have an adverse effect on the monthly publications. Ms. Greer's idea saves \$3,276 annually.
4025 Rodger A. Blakey	Transportation	\$230	Mr. Blakey is a sign painter in the Streets Division. He suggested that traffic signs be repainted rather than purchasing new signs. This idea saved the City \$2,316 in the first year of operation.
5015 David R. Hughey Francis L. Clemings	Park and Recreation	\$150	One year ago these suggesters recommended that extra loops be welded on basketball rims to double the time between rim repair. This is an additional award based on \$1,500 additional savings.
4030 Rodger A. Blakey	Transportation	\$135	Mr. Blakey is a sign painter in the Streets Division. He suggested that lettering on doors and windows be done through a silk-screening process rather than using "gold leaf" lettering. This idea saved the City \$1,345 in the first year of operation.
5465 Frank O. Lovett	Park and Recreation	\$120	Mr. Lovett is a Carpenter in the Aquatics Division. He designed a wooden navigational buoy to replace the fiberglass buoys formerly used. This saves the City \$1,187 annually.
