5004 Sophia C. Vidmar	Housing and Community Services	\$95	One year ago Ms. Vidmar suggested a revision to a filing system. A year's experience substantiated an additional \$933 in savings.
4484 James R. Schwarz	Park and Recreation	\$20	Mr. Schwarz is a Groundskeeper in the Park Division. He suggested that a hydraulic jack be used to remove tree stakes. Although this tool can not be used in every situation, an annual savings of \$200 was estimated.
5191 Clay F. Reynard	Police	\$15	Mr. Reynard is an Identification Technician. He suggested that Police Officer applicants be required to prepare their own fingerprint cards. This has saved \$165 in the first year of use.
5572 Gordon B. Russell	Transportation	\$15	Mr. Russell is an Electronic Technician in the Communications and Electrical Division. He suggested a method of preventing audio board contact pin damage by using a silicone compound grease. This is a partial award pending a final 12-month review.
