David W. Wilhite	Park and Recreation	\$ 15	Mr. Wilhite is a Lifeguard in the Aquatics Division. He suggested international swim and surf signs be used at public beaches. This is considered to be a significant safety idea.
Domingo Monjarez	General Services	\$ 10	Mr. Monjarez is an Equipment Maintenance Supervisor in the Equipment Division. He suggested that all trash packers be brought into the service station at the end of the day for normal maintenance. Although this specific idea was not adopted, Sanitation Drivers are expected to write up any defects in their motive equipment at the end of each shift. This is expected to be a significant preventive maintenance idea.
Thomas B. Frost	Park and Recreation	\$ 10	Mr. Frost is a Senior Engineering Aide in the Parks Division. He suggested that optical tape measures be used by City departments. As a result of his suggestion, the Utilities Department has purchased two of these handy instruments.
