BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$281,185.08 by T. B. Penick & Sons, Inc., a corporation, for THE IMPROVEMENT OF BALBOA/ECC BLOCK GRANT STREETS AND ALLEYS CONTRACT NO. 4 in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 761656.
2. That the expenditure of \$343,457.00 is hereby authorized out of the Second Year Block Grant Fund 290 and that the expenditure of \$18,543.00 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
