APPROVING MAP OF SAN CARLOS VILLAGE SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by LAWRENCE HIRSCH, a Registered Civil Engineer, entitled "SAN CARLOS VILLAGE Being a subdivision of portions of Lots I and J of the Partition of Lot 70 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Partition Map thereof made under the action entitled 'San Diego Realty Company vs. Maria Y. Olvera De Toro, et al' under Superior Court Civil Case No. 15191 on file in the office of the County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Whelan Drive and a portion of Tommy Street for public purposes; and said street and portion of a street are hereby declared to be public streets and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water facilities as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that
