

RESOLUTION NO. 220173

WHEREAS, local coastal program regulations pursuant to the 1976 California Coastal Act require the submittal by local governments to the coastal commissions of issues identification prior to submittal of the local coastal program; and

WHEREAS, the Local Coastal Program Regulations require the submittal of a total work program by local governments seeking State or Federal funding for preparation of local coastal programs; and

WHEREAS, the Planning Department has prepared draft local coastal program outlines including issue identification reports and work programs for the Pacific Beach Community Plan Revision, Barrio Logan Community Plan and the Peninsula Community Plan Revision; and

WHEREAS, it is appropriate to insure that the above mentioned work programs adequately address the issues identified in the respective Issues Reports; and

WHEREAS, there has been adequate informal staff review of the above mentioned documents between the staffs of the Planning Department and the San Diego Coast Regional Commission; and

WHEREAS, the Planning Department has submitted the above mentioned documents to the City Council Rules Committee for consideration, and the Rules Committee has reviewed this material and found it appropriate with respect to implementing the Coastal Act; NOW, THEREFORE,

That the City Council formally approve the submission to the coastal commissions of the local coastal program outline including issue identification and work programs, said documents are on file in the office of the City Clerk as:
