JAN 31 1978

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Public Resources Code, Section 21081, the following findings are made with respect to the environmental impacts identified in Environmental Impact Report No. 77-05-31:

Impact: The project would facilitate development in an
area designated for open space by the adopted Torrey Pines
Community Plan, thereby precluding future options for acquisition.

Mitigation: This impact is unmitigatable; either the property is acquired for open space, or it is developed. However, this project does satisfy the Community Plan's secondary alternative calling for very low density residential development in the event acquisition is not accomplished. This area's rural character would be retained if, as proposed, just 3 additional, single-family residential structures are constructed.

Impact: Development east of San Dieguito Drive could intrude
upon and possibly block the existing functional integration
between two valuable, expansive environmental resource areas,
Crest Canyon and the San Dieguito Lagoon.

Mitigation: Implementation of the revised Parcel Map would mitigate this impact to a level of insignificance. Five acres on the western portion of Parcel 4 would be dedicated as open space. Additionally, Parcel 1 would be terminated 475 feet east of San Dieguito Drive, thus eliminating any legal or physical barriers between Crest Canyon and the lagoon.

Impact: The proposed parcelling precedes the San Dieguito
Lagoon Management Plan which is currently being prepared by
the City of Del Mar for State Coastal Act certification. The

project site is within the study area, and any urbanization within the lagoon environs may preclude options and opportunities for planning for the lagoon.

<u>Mitigation</u>: The parcel map has been revised to provide a linkage between the Crest Canyon and the San Dieguito Lagoon which will mitigate the identified impact.
