APPROVING MAP OF NORTH RIM SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by DON NASLAND, a Licensed Land Surveyor, entitled "NORTH RIM Being a subdivision of Parcel 2 of Parcel Map No. 5465, in the City of San Diego, County of San Diego, State of California, filed in the office of County Recorder of San Diego County, being a division of that certain parcel of land delineated and designated as Parcel 7 on Record of Survey No. 4212 filed in the office of County Recorder of San Diego County, March 1, 1957 being portions of Pueblo Lots 1175 and 1176 of the Pueblo Lands of San Diego.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Northrim Court for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements listed in paragraphs 1 and 2 of the Owner's certificate, as shown on this map and subject to the conditions set forth thereon.
