LEGAL DESCRIPTION

PORTION STREET RESERVATION IN PARCEL 1  
PARCEL MAP NO. 5465 DEDICATED

THAT PORTION OF PARCEL 1 OF PARCEL MAP NO. 5465, DESCRIBED AS  
FOLLOWS:

BEGINNING AT THE MOST EASTERLY CORNER OF SAID PARCEL 1, SAID CORNER BEING AT THE INTERSECTION OF THAT COURSE HAVING A BEARING OF NORTH 80°54'42" WEST AND THAT COURSE HAVING A BEARING OF NORTH 13°31'28" EAST, AS SHOWN ON SAID PARCEL MAP; THENCE ALONG THE BOUNDARY OF SAID PARCEL 1 NORTH 80°54'42" WEST, 24.07 FEET; THENCE NORTH 13°31'28" EAST, 230.94 FEET TO THE BEGINNING OF A TANGENT 446.00 FOOT RADIUS CURVE, CONCAVE WESTERLY; THENCE ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 49°48'34" A DISTANCE OF 387.73 FEET TO A POINT ON SAID CURVE, A RADIAL TO WHICH BEARS NORTH 53°42'54" EAST, SAID POINT ALSO BEING A POINT ON A NONTANGENT 464.00 FOOT RADIUS CURVE, CONCAVE SOUTHWESTERLY, A RADIAL TO WHICH BEARS NORTH 63°12'50" EAST; THENCE ALONG THE ARC OF THE LAST SAID CURVE THROUGH A CENTRAL ANGLE OF 13°41'51" A DISTANCE OF 110.92 FEET; THENCE TANGENT TO SAID CURVE NORTH 40°29'01" WEST 145.83 FEET TO THE BEGINNING OF A TANGENT 20.00 FOOT RADIUS CURVE, CONCAVE SOUTHERLY; THENCE ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 90°00'06" A DISTANCE OF 31.42 FEET TO A POINT OF CUSP ON THE SOUTHEASTERLY LINE OF THAT 25 FOOT PORTION OF LINDA VISTA ROAD DEDICATED PER DEED RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY ON OCTOBER 10, 1960, AS FILE/PAGE NO. 201982, SERIES 1, BOOK 1960; THENCE ALONG SAID SOUTHEASTERLY LINE NORTH 49°30'53" EAST, 12.00 FEET TO THE BEGINNING OF A TANGENT 20.00 FOOT-RADIUS CURVE, CONCAVE SOUTHERLY; THENCE ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 90°00'06" A DISTANCE OF 31.42 FEET; THENCE TANGENT TO SAID CURVE SOUTH 40°29'01" EAST 223.05 FEET TO THE BEGINNING OF A TANGENT 470.00 FOOT-RADIUS CURVE, CONCAVE WESTERLY; THENCE ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 54°00'29" A DISTANCE OF 443.03 FEET; THENCE TANGENT TO SAID CURVE SOUTH 13°31'28" WEST, 229.08 FEET TO THE POINT OF BEGINNING.
