
Adopted on FEB 1 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of Francis W. Parker School, a nonprofit corporation, executed in favor of The City of San Diego, bearing date of December 1, 1977, conveying to said City the permanent easement and right of way for a public street, and incidents thereto, over, under, upon, along and across all that real property in that portion of Parcel 1 of Parcel Map 5465, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named NORTHRIM COURT.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.
