BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant Deed of DIOCESE OF SAN DIEGO EDUCATION AND WELFARE CORPORATION, a corporation, executed in favor of The City of San Diego, bearing date of July 29, 1977, conveying to said City a portion of Lots A-85, A-1 and A-2 of San Ysidro, which property has a value, including severance damages to adjacent property, of \$14,850 as determined by an Independent Fee Appraisal dated March 25, 1977, as more particularly described in said deed.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$18,570, which includes \$18,300 as the negotiated settlement value of the land, together with severance damages, for such acquisition and related expenses, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
