Said Council hereby finds that that certain map surveyed
by RONALD D. HOGAN, a Registered Civil Engineer, entitled
"BAY TERRACE GLENS Being a subdivision of Lot 493 of Bay
Terrace Unit No. 1, in the City of San Diego, County of San Diego,
State of California, according to Map thereof No. 6659 filed
in the office of County Recorder of San Diego County, June 1,
1970, together with a portion of Paris Way, Ramfos Place and
Aegean Drive, as dedicated to public use.", in made in the
manner and form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown thereon
is hereby approved and accepted; and said Council hereby accepts
on behalf of the public, the following: Simi Place, Simi Court,
and Zulu Way, for public purposes; and said streets are hereby
declared to be public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
said public streets are accepted on behalf of the public as
heretofore stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges
receipt of assurance from the subdivider SUNBURST HOMES CORPORATION,
a California corporation, that said subdivider will comply with
