

That portions of Lots 155 and 156 of La Mesa Colony, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 876, filed in the office of the San Diego County Recorder, as more particularly described in the document attached hereto as Exhibit A and incorporated herein, are hereby set aside and dedicated as and for a public street, and the same is hereby named KIOWA DRIVE.

LEGAL DESCRIPTION

Those portions of Lots 155 and 156 of La Mesa Colony, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 876, filed in the Office of the County Recorder of San Diego County on September 4, 1901, more particularly described as follows:

Commencing at the Southwest corner of said Lot 156, La Mesa Colony; thence along the Southerly boundary of Lot 156, South 89°29'16" East a distance of 140.12 feet to the TRUE POINT OF BEGINNING; thence continuing along the Southerly boundary of Lot 156 South 89°29'16" East a distance of 60.02 feet; thence North 01°02'20" West a distance of 221.29 feet to a point on the boundary between the City of San Diego and the City of La Mesa; thence along said boundary South 89°29'16" West a distance of 14.90 feet; thence continuing along said boundary North 43°52'25" East a distance of 14.02 feet; thence leaving said boundary South 88°57'40" West a distance of 89.00 feet; thence South 01°02'20" East a distance of 58.00 feet to a point in the arc of a tangent 47.00 foot radius curve concave Northeasterly; thence Southerly and Southeasterly along the arc of said curve, through a central angle of 60°29'33" an arc length of 49.62 feet to a point of compound curvature and being a point in the arc of a tangent 20.00 foot radius curve concave Southwesterly; thence Southeasterly and Southerly along the arc of said curve, through a central angle of 60°29'33" an arc length of 21.12 feet; thence South 01°02'20" East a distance of 113.42 feet returning to the TRUE POINT OF BEGINNING.

Basis of Bearings: The Northerly line of the most Westerly portion of R.O.S. 7079, being a portion of Lot 156, La Mesa Colony, i.e. North 84°48'28" West.
