BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of CECIL HARRIS, executed in favor of The City of San Diego, bearing date of October 28, 1977, granting to said City a permanent easement and right of way for public street and incidents thereto over, under, along and across those portions of the East 92.00 feet of Lot 6, Block 5 of Lisbon Townsite, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named JAMACHA ROAD.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
