WHEREAS, The Transportation Department has prepared plans for a 50-foot wide street, extending approximately 550 feet northerly of the existing right-of-way; and

WHEREAS, the project is in the older urbanized area and will qualify under Council Policy 200-3 for a City contribution of 50 percent of the cost, which contribution is presently estimated at \$45,000; and

WHEREAS, there are 12 property owners involved in the right-of-way dedication and it is necessary that the City acquire the street easement from the owners and charge the expenditure back to the project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of not to exceed \$25,000 from

Fund 2388 for acquisition purposes for dedication and improvements of 71st Street is hereby authorized and approved.
