BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager is hereby authorized and empowered to do by City Forces all the work to construct corner Blind Strips as required in connection with the REMOVAL OF ARCHITECTURAL BARRIERS FOR THE BLIND HANDICAPPED - CONTRACT NO. 7, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$12,200.00
2. That the expenditures of \$11,850.00 from Second Year Block Grant Fund 290 and \$350.00 from Capital Outlay Fund 245 Reserve of the City of San Diego are hereby authorized solely and exclusively for providing funds for said project and related costs.
