PHELPS, a Registered Civil Engineer, entitled "CREST MAR PARK Being a resubdivision of Lots 1, 2 and 3 of Crest Mar Industrial Park Unit No. 1, Map No. 7817 together with portions of the NW 1/4 of NW 1/4 and SW 1/4 of NW 1/4 of Section 11, Township 15 South, Range 3 West S.B.M. together with portion of Carroll Road as dedicated to public use on Map 7817, and Crest Mar Road as closed & vacated to public use per Resolution # 220269 dated FEB 8 1978 all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.
