WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street to be vacated has been superseded by relocation; and

WHEREAS, CRESTMAR ROAD has been relocated through the creation on this date of the lots in the subdivision known as Crest Mar Park; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access or will be accessible because of the nature of the lots created with the approval on this date of the subdivision known as Crest Mar Park;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That CRESTMAR ROAD, as more particularly shown on Drawing No. 13995-B on file in the office of the City Clerk as Document No. 762636, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
