

RESOLUTION No. 220270 (R. 78-1327)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$25,000 from Community Development Block Grant (CDBG) Fund 2930, Element 86.92 (California Housing Finance Agency Neighborhood Preservation - Golden Hills) to Fund 2930, Element 86.93 (Reinvestment Strategy Project).

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with URBAN PROJECTS, INCORPORATED, for the development of a strategy for promoting public and private cooperation for reinvestment in declining residential areas of the City of San Diego, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 763043.

That the consultant is hereby directed and authorized to include the University of Miami's nation-wide study on redlining in his report.
