RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO, CALIFORNIA, REPEALING
RESOLUTIONS NUMBERS 219903, 219904,
AND 219905 ADOPTED ON DECEMBER 14, 1977,
IN THE MATTER OF PROPOSED BEYER BOULEVARD,
DAIRY MART ROAD TO I-805, ASSESSMENT
DISTRICT.

WHEREAS, in the matter of proposed Beyer Boulevard,
Dairy Mart Road to I-805, Assessment District, the Council
at its meeting of December 14, 1977 adopted its resolution
of intention, Resolution No. 219903, ordering the Superintendent
of Streets to prepare the Report required by the Municipal
Improvement Act of 1913 and pursuant thereto, the Superinten-
dent of Streets thereupon submitted the Report; and

WHEREAS, at said meeting of December 14, 1977 the Council
also adopted Resolution No. 219904 approving the Report and
fixing it for hearing and Resolution No. 219905 inviting
construction bids and bond bids; and

WHEREAS, the said resolutions and Report were incorrect in
certain particulars and the Council desires to repeal said
resolutions and to rescind its approval of said Report; and

WHEREAS, the City Clerk has not filed with the County
Recorder a copy of the map of the assessment district approved
by Resolution No. 219903; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. Resolutions Nos. 219903, 219904 and 219905 are hereby repealed. The Council hereby rescinds its approval of the Report submitted at the meeting of December 14, 1977 and directs the City Clerk to note the fact of rescission on the cover sheet of that Report.

Section 2. The Council declares that, by adoption of this resolution, it does not intend to abandon proceedings for the proposed project and assessment district but, following adoption of this resolution, intends to reinitiate the proposed project and assessment district by the adoption of new resolutions and the submission of a new Report. Accordingly, the City Clerk is directed not to file a certificate of abandonment with the County Recorder.
