BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those Grant and Slope Easement Deeds of TOM T. TSUNADA and MICHIKO TSUNADA, executed in favor of The City of San Diego, bearing dates of December 21, 1977, conveying to said City all that portion of Lot 11 of Cave and McHatton Subdivision, according to Map thereof No. 159 filed in the Office of the San Diego County Recorder, as more particularly described in said deeds, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named SKYLINE DRIVE.

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that Slope Easement Deed of J.B. HEMPHILL and LARRY P. LOGAN, as tenants in common, executed in favor of The City of San Diego, bearing date of December 23, 1977, conveying to said City the permanent easement and right of way for an earth excavation or embankment, slope or slopes and incidents thereto, over, under, upon, along and across all that portion of Lot 13 of Cave and McHatton, according to Map thereof No. 159 filed in the Office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved.


