

RESOLUTION No. 220294 (R-78-1391)


Adopted on FEB 15 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of CAMERON BROS. CONSTRUCTION COMPANY, INC., a partnership, executed in favor of The City of San Diego, bearing date of July 21, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across that portion of Lot 46 of the Highlands, according to Map thereof No. 284, filed in the office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named DAGGET STREET.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
