RESOLUTION ORDERING WORK FOR THE CONSTRUCTION OF VARIOUS IMPROVEMENTS IN 61ST STREET FROM SKYLINE DRIVE TO IMPERIAL AVENUE AND OF A SEWER MAIN IN BENSON AVENUE FROM 61ST STREET TO 65TH STREET.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the public interest and convenience require the improvement herein referred to, and that this Council hereby orders the work and improvement as described in Resolution of Intention No. 218652, passed and adopted by the City Council on June 22, 1977, and as amended by Resolution No. 219202, passed and adopted by the City Council on August 31, 1977, and as later amended by Resolution No. 219762, passed and adopted by the City Council on November 23, 1977, be done and made.

2. That the boundaries of the district to be assessed and the grades to which said work is to be done, shall be those described in said Resolution of Intention, and the plans, profiles and specifications therein referred to, reference to which is hereby made to all particulars.
