RESOLUTION AWARDING A CONTRACT TO IMPROVE
61ST STREET BETWEEN SKYLINE DRIVE AND
IMPERIAL AVENUE, BENSON AVENUE FROM 61ST
STREET TO 450 FEET EASTERLY, AND SKYLINE
DRIVE AT 61ST STREET.

1. That the Council of The City of San Diego, California, hereby rejects all said proposals or bids except that herein mentioned and hereby awards the contract for doing said work and improvement to the lowest regular responsible bidder, to wit:

at the prices named in the bid of said bidder on file in the office of the City Clerk.

2. That the City Clerk is hereby directed to cause notice of this award to be published twice in the City Official Newspaper and to record notice of this award in the office of the County Recorder as provided in Section 5248 of the Streets and Highways Code.
