BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by RAYMOND F. HALL, JR., a Registered Civil Engineer, entitled "EMPIRE DEVELOPMENTS UNIT NO. 6 Being a subdivision of the easterly one-fourth of Lot 40 of The Highlands, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 284 filed in the office of the County Recorder of San Diego County, March 16, 1887, together with portions of Clairemont Mesa Boulevard, Mercury Street (formerly Mesa Street), and Raytheon Road all as dedicated to public use, and together with a portion of Clairemont Mesa Boulevard as closed and vacated to public use." is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


