

RESOLUTION NO. 220321

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Willie M. Gipson	General Services	\$985	One year ago Mr. Gipson suggested that fire extinguishers for all trash packers be placed in charge of supervisors. He received a \$15 safety award at that time. In the past year, nine fires have been extinguished with these extinguishers with no damage experienced. Previous to the implementation of this idea, two packer cabs had been destroyed by fire, and the cost to replace these cabs was in excess of \$30,000. The total first year savings of Mr. Gipson's idea is in excess of \$110,000. This is the remainder of his award.
Neil E. Tucker	Water Utilities	\$850	One year ago Mr. Tucker suggested that the Water Utilities Department replace the wood shoring method with the steel cylinder shoring method of reinforcing for the repair of deep sewer laterals. He received \$150 at that time. In the past year Mr. Tucker's idea has save the City a total of \$41,392. This is the remainder of his award.
William H. Dinneen George G. Montague	General Services	\$290	One year ago Mr. Dinneen and Mr. Montague suggested that other governmental agencies be charged for the use of City landfills. They received \$500 at that time. In the first year of operation a total of \$7,890 of increased revenue was recorded. This is the remainder of their award.
