Riny J. Snyder Joseph A. Rametta Larry Heath John E. Russell	Purchasing	\$80	These four suggesters work in the Print Shop. They suggested that an automatic jogger be purchased to ready large printing jobs for binding. This will reduce the amount of time it takes to bind thick publications. Total savings is expected to be \$1,080. This is a partial award pending final 12-month review.
Carmen C. Lutes	Engineering and Development	\$75	Ms. Lutes is an Intermediate Stenographer. She suggested that application and permit forms be combined into one. This idea is expected to save \$1,760 in the first year of operation. This is a partial award pending a final 12-month review.
Nancy A. Neu	Library	\$65	Ms. Neu is an Intermediate Typist. She suggested that a form letter be used to ask further information from Library patrons returning overdue books. This idea is expected to save \$1,643 in the first year of operation. This is a partial award pending a final 12-month review.
Walter T. Wickware	General Services	\$65	Mr. Wickware is a Senior Disposal Supervisor in Solid Waste. He suggested that a scraper be modified to remove two unneeded ripper teeth. This equipment is used to haul cover and resurface dirt. This is expected to save \$1,635 in the first year in the replacement of ripper teeth. This is a partial award pending a final 12-month review.
