WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Danny A. Lewis	Engineering and Development	\$50	Mr. Lewis is an Intermediate Typist. He suggested that contractors be required to supply an extra copy of Affirmative Action reports. This is expected to save \$904 annually in the time it takes City personnel to copy these documents. This is a partial award pending final 12-month review.
Budd Q. Neel	General Services	\$50	Mr. Neel was a Principal Sanitation Supervisor in Solid Waste at the time of his suggestion. He suggested that uniforms be purchased for Solid Waste employees and that the employees be allowed to maintain them. This is expected to save the City \$2,388 annually over the cost of uniform service. This is a partial award pending a final 12-month review.
David W. Wilhite	Park and Recreation	\$20	Mr. Wilhite is a Lifeguard in the Aquatics Division. He suggested that "No Lifeguard On Duty" signs be relocated and redesigned. This results in a larger and more visible sign. This is a safety award.
Rhoda E. Kruse	Library	\$15	Ms. Kruse is a Senior Librarian. She suggested that NCR paper be used for photocopy request form pads and receipt books at the Library. This is expected to save \$150 annually.
