- That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf fo The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as 762793 , quitclaiming to WESLEY LEE Document No. STARK, JR., an unmarried man, an easement and right-of-way for slope purposes affecting Lot 1, Block 71, Middletown Addition, as more particularly described in said form of quitclaim deed.
- That no broker's commission shall be paid by City on the herein described negotiated sale.
- That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
