BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Change Order No. 2, dated January 16, 1978, heretofore filed with the City Clerk of said City as Document No. 762806, issued in connection with the contract between The City of San Diego and H. L. Foster Construction Company for the IMPROVEMENT OF LOGAN AVENUE, KEELER AVENUE, BETA STREET, 42ND STREET AND 45TH STREET-CONTRACT NO. 2, said contract having been filed in the office of the City Clerk as Document No. 761857, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$8,817.10 and an extension of time of 15 days extending the completion date to 165 work days, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$13,617.00 is hereby authorized out of Water Utility Revenue Bond Fund 502 of The City of San Diego, solely and exclusively, for the purpose of providing funds for the above project and related costs.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces all the work of making the connection to the existing water system and other related work for the above mentioned project, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract and that the cost shall not exceed \$2,800.00.
