

RESOLUTION No. 220336 (R. 78-1470)

Adopted on FEB 22 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a parking time limit of two hours, between the hours of 8:00 a.m. and 6:00 p.m., Saturdays, Sundays and certain holidays excepted, be and the same is hereby established on the following street in said City:

South side of MILDRED STREET, between
Goshen Street and the easterly dead end.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
