
Adopted on FEB 22 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of JAMES L. ELLIS and BARBARA G. ELLIS, husband and wife, executed in favor of The City of San Diego, bearing date of August 5, 1977, conveying to said City an easement for right of way for a public street, and incidents thereto, through, over, under, upon, along and across those portions of Lot 1, Block 275 and Right of Way Lot 60 of Middletown, according to Partition Map thereof made by J.E. Jackson, on file in the office of the County Clerk of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named LAUREL STREET.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
