BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Public Resources Code, Section 21081, the following finding is made with respect to the environmental impacts identified in Environmental Impact Report No. 77-08-36:

Impact: Noise. The project will incorporate architectural and construction techniques that will reduce interior noise levels to an acceptable level, thereby mitigating such noise impacts to a level of insignificance. Exterior noise levels cannot be mitigated during hours that the San Diego International Airport operates, since the developer cannot control the noise source. However, the proposed project will make available housing for elderly and low-income tenants that is desperately needed and unavailable. The provision of this type housing is an overriding factor, the social benefits of which justify approval of the project notwithstanding the unmitigated noise impact.
