WHEREAS, it is proposed that a public walkway adjacent to southerly lot line of Lot 127, Penasquitos Glen, Unit #6, Resubdivision Map 7856 be vacated; and

WHEREAS, there is no present or prospective use for the walkway either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that a public walkway adjacent to southerly lot line of Lot 127, Penasquitos Glen, Unit #6, Resubdivision Map 7856, as more particularly referred to in Resolution of Intention No. 220100, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that a public walkway adjacent to southerly lot line of Lot 127, Penasquitos Glen, Unit #6, Resubdivision Map 7856, as more particularly shown on Drawing No. 14142-B on file in the office of the City Clerk as Document No. 762396, which said Drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.

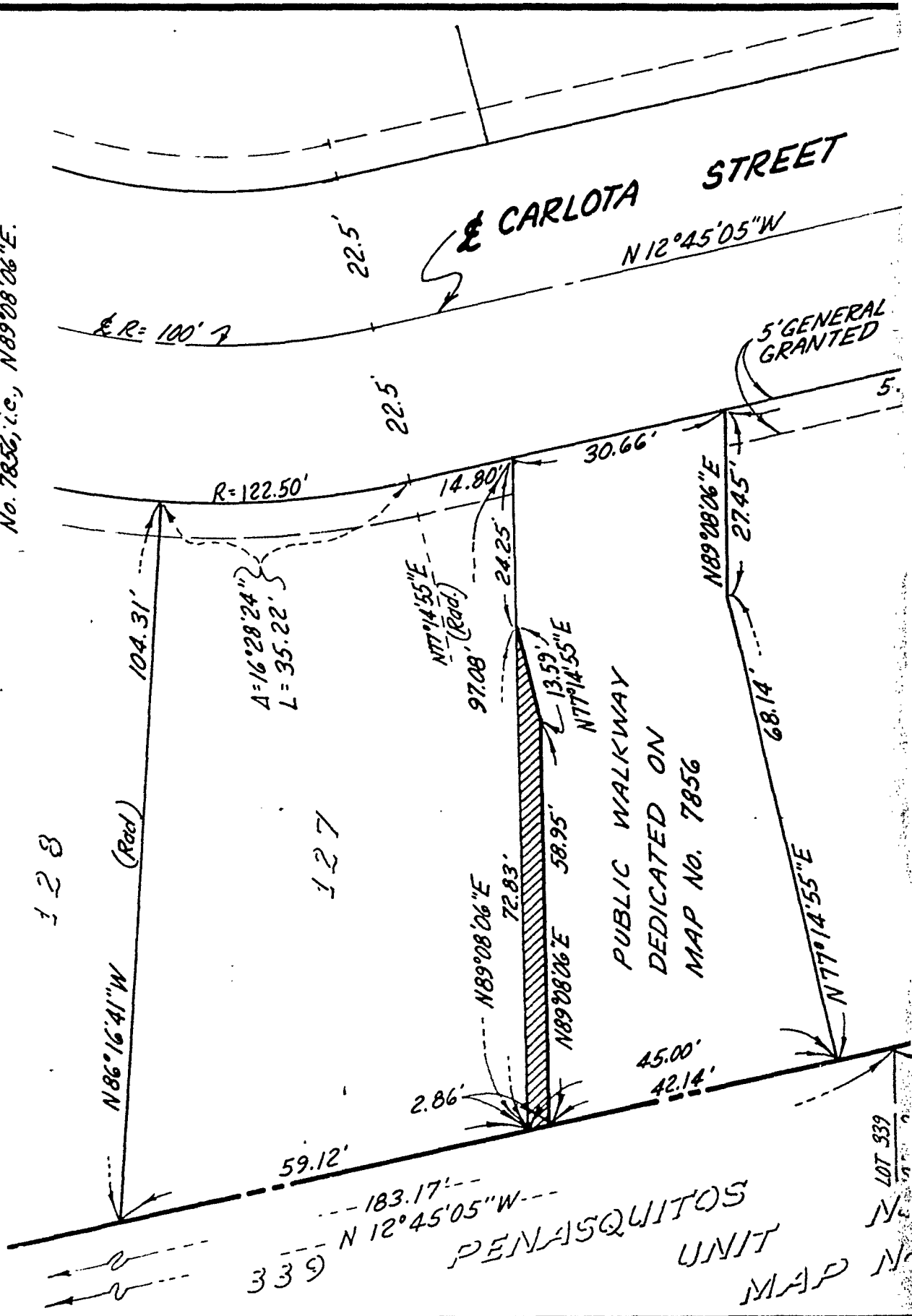

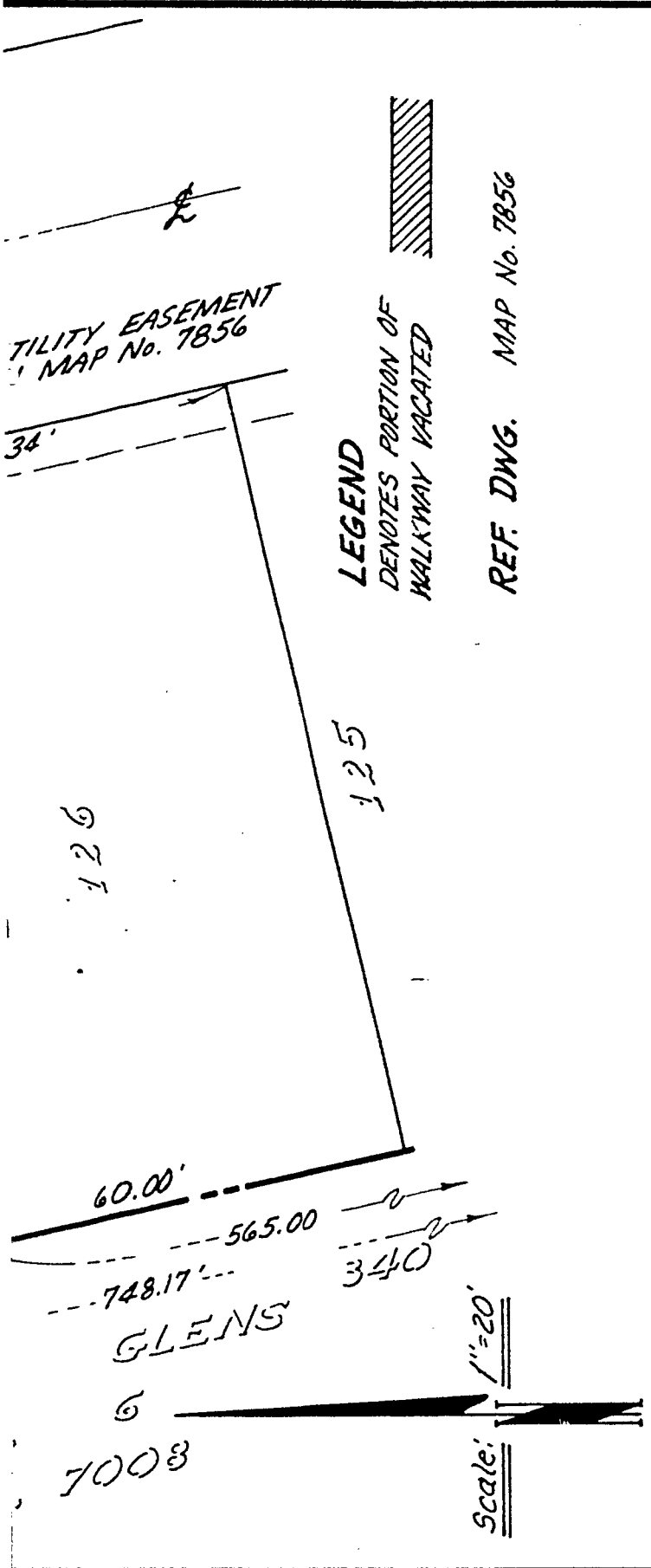
