Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "LEM HEIGHTS Being a subdivision of all of that portion of Lot 40 of Rancho Mission of San Diego, together with a portion of Sandrock Road as dedicated to public use, in the City of San Diego, County of San Diego, State of California, according to Partition Map in Superior Court Case No. 348, of San Diego County, entitled 'Juan M. Luco, et al, vs. Commercial Bank of San Diego, et al.'", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the constructon and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those certain easements for sewer and drainage facilities as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.
