RESOLUTION NO. 220359 (R.78-1476)

APPROVING MAP OF MISSION HEIGHTS NORTH UNIT NO. 7  
SUBDIVISION AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S  
ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING  
PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by  
BYRL D. PHELPS, a Registered Civil Engineer, entitled "MISSION  
HEIGHTS NORTH UNIT NO. 7 Being a subdivision of a portion of  
Pueblo Lot 1181 of the Pueblo Lands of San Diego in the City  
of San Diego, County of San Diego, State of California, according  
to Map thereof made by James Pascoe in 1870 and recorded  
November 14, 1921 as Miscellaneous Map No. 36, together with a  
portion of Hanford Drive in Mission Heights North Unit No. 6,  
according to Map thereof No. 6340 as closed and vacated to  
public use." is made in the manner and form prescribed by  
law and conforms to the surrounding surveys; that said map  
and the subdivision of land shown thereon is hereby approved  
and accepted; and said Council hereby accepts on behalf of the  
public, the following: Hanford Drive for public purposes; and  
said street is hereby declared to be a public street and  
dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts  
on behalf of The City of San Diego, a municipal corporation,  
the easements with the right of ingress and egress for the  
construction and maintenance of sewer and drainage facilities,


as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those certain easements for sewer and drainage facilities as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, CAMERON BROS. CONST. CO., INC., a California corporation, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of MISSION HEIGHTS NORTH UNIT NO. 7.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
