BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- That a portion of HANFORD DRIVE, as more particularly shown on Drawing No. 14019-B on file in the office of the City Clerk as Document No. 762825 , which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.


